### Context

Being a large restaurant chain in Quebec with 46 restaurants, Benny&Co. was faced with a relatively complicated accounts payable process. The organization received invoices at its head office and these had to then be rerouted to the corporate restaurants for approval. After that, the invoices had to be sent back to the head office so the accounts payable team could finish manually entering the data into the accounting system.

This process involved a great deal of "back and forth" of documents, resulting in significant amounts of time wasted. Additionally, archiving of paper invoices had started to become a problematic situation, requiring more and more physical space in which to archive these invoices. This manual process also had an impact in terms of operations, often causing the organization to be in a situation where invoices were being processed late. Benny&Co. was dealing with another issue as well, this time regarding approval of payments to suppliers. To sign these checks, signatories had to physically travel around, which meant even more time wasted.
